# **Movax Information Management System**

Movax Oy (hereinafter "MOVAX") may collect, store and process personal data as a controller in connection with Movax Information Management System ("MIMS"), in order to provide such system for you. MOVAX is committed to applicable legislation in its operations and we collect, store and process your personal data in accordance with the privacy policy described below.

### 2 PROCESSING IN CONNECTION WITH MIMS

MOVAX may process your personal data in connection with MIMS for the purpose of providing MIMS for your use. The possible personal data processed by MOVAX is limited to the username, which may consist of your e-mail address, that you use when you log in to MIMS. MOVAX has received such e-mail address either from you directly or from an employee/representative of the company that you work for. MOVAX does not collect any other personal data relating to you in connection with MIMS.

MOVAX's right to process your personal data is based on a legitimate interest created by the customer relationship that MOVAX has with you directly or with the company you are an employee or representative of. If you do not provide your e-mail address, it might be that you are not able to access MIMS, depending on for example, whether there is another e-mail address available that may be used as a username.

MOVAX will process your personal data only for as long as it is necessary in order to provide MIMS for you, i.e. for as long as you are using MIMS, or for a longer period, if so required by the applicable legislation.

# 3 SHARING AND TRANSFERRING PERSONAL DATA

We may use subcontractors in the processing of your personal data. Such subcontractors process your personal data on behalf of MOVAX and are not allowed to use your personal data for their own purposes. Otherwise we do not disclose your personal data to third parties, unless we are required to do so under applicable laws.

MOVAX does not regularly process personal data outside the EU or EEA. However, if MOVAX processes your personal data outside the EU or EEA, it is done in compliance with the applicable data protection legislation and MOVAX will makes sure that appropriate measures are implemented to ensure the security of such personal data.

### 4 YOUR RIGHTS

As a data subject, you have the right to request a copy of personal data relating to you, request for the correction of incorrect personal data relating to you, and the deletion of your personal data. Furthermore, you are entitled to request for the restriction of processing of your personal data and object to such processing. In certain situations you have the right to data portability, which means that you can request for having your personal data in commonly used, machine-readable format and you may request that your personal data is transmitted to another controller, if it is technically feasible.

Should you feel that your rights under the applicable legislation have been infringed, you are entitled to lodge a complaint with the supervisory authority.
